Overall Purpose of Job

To maximise opportunities for children and young adults supported by Birtenshaw to participate in a full range of gym based and sporting activities.

Key Responsibilities

- 2. To develop and maintain links with other private, statutory and voluntary organisations that are able to offer opportunities for sporting and recreational activities.
- 3. To deliver, plan and evaluate P.E lessons following a curriculum in a school environment.
