



Comments on Rates and Trends

Although the number of discharges this month was slightly increased on last month, this was more than compensated for in a very large increase in the number of admissions to care. Number of adoptions was down this quarter.






Looked After Children Placed with Parents by Legal Status and District - December 2016











Comments on Placements


Bolton continues to maintain it's low rates of Out of Borough placements. The fall in the proportion of children placed with parents continues though Bolton's rates remain above the most recent data we have for comparator authorities. The increase in the number of children placed with in house foster carers has been sustained. The slow increase in the number of children in kinship care placements appears to have ended. Numbers of adoptive placements have fallen slightly - adoptive placements remain at a comparatively low level, though Bolton still places more children for adoption than its peers.



Comments on Miscellaneous

It is important to recognise that the data reported for PEPs relates only to PEPs recorded on Liquid Logic using our refreshed PEP processes and does not incude a measure of how frequently PEPs have been updated - this is subject to separate discussions.

Data relating to the wellbeing of care leavers is calculated using locally meaningful definitions which do not correspond exactly to definitions in DfE Stat Releases. Data published by DfE suggests that Bolton has a higher proportion of care leavers NEET than our comparators, but that this may be attributable to our success in keeping in touch with our care leavers, as we also have higher rates of care leavers in EET and a low rate of "not knowns". The national data suggests that Bolton is particularly effective at supporting care leavers into HE. Comparator data published by DfE further suggests that Bolton now has a slightly higher proportion of care leavers living in suitable accommodation than is the case nationally.

Data on staff vacancy rates was calculated using local definitions which do not correspond exactly with definitions in the Social Care Workforce Return submitted to DfE.
