
DBS Changes to rules for Identity checking - updated September 2018

As of October 20017 there are changes to the rules for ID checking depending on where you are from. Follow the simple process guide below to determine which route you should follow:



The detailed documentation you need to provide is outlined over the next few pages.

What detailed documentation should I provide?

A - If you are from the UK or the European Economic Area

You must prove your identity as part of the DBS check process. You must provide original documents (not copies) to do this. You must try to provide documents from Route 1 before Route 2 or Route 3.

If you're not a national of the UK or the European Economic Area (EEA) you must use a different route to apply for **paid work** in the UK. You *can* use Route 1 for voluntary work.

Route 1 - You must be able to show:

- one document from Group 1
- 2 further documents from either Group 1, or Group 2a or 2b

At least *one* of the documents must show your current address.

If you're not a national of the UK or the EEA and you're applying for voluntary work you may need to be fingerprinted if you can't show these documents.

Route 2 - If you don't have any of the documents in Group 1, then you must be able to show:

- one document from Group 2a
- 2 further documents from either Group 2a or 2b

At least one of the documents must show your current address. The organisation conducting the ID check must then also use an appropriate external ID validation service to check the application.

If you're an EEA national who's been resident in the UK for 5 years or less you may need to be fingerprinted if you can't show these documents.

Route 3 - can only be used if it's been impossible to process the application through Routes 1 or 2. EEA nationals who've been resident in the UK for 5 years or less can't use Route 3.

For Route 3, you must be able to show:

- a birth certificate issued after the time of birth (UK and Channel Islands)
- one document from Group 2a
- 3 further documents from Group 2a or 2b

At least *one* of the documents must show your current address. If you can't provide these documents you may need to be fingerprinted.

B – if you're from outside the UK or European Economic Area

If you are applying for a DBS check to do paid work and you aren't a national of the UK or European Economic Area (EEA), you must be able to show:

- one primary document
- 2 supporting documents

You must provide original documents (not copies) to prove your identity. At least one of the documents must show your current address.

You can't use any other route for paid work but can use Route 1 if its for voluntary work.

Primary Documents

Document	Notes
	Issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
A current Biometric	Previously (Biometric Residence Permit) Issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
A current passport	Must be endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
C C	Issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no

Document	Notes
	time limit on their stay in the UK, together with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
A current passport	Must be endorsed to show that the holder is allowed to stay in the UK and is currently allowed to do the type of work in question
A current Biometric Immigration Document (Biometric Residence Permit)	Issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to do the work in question
A current Residence Card	This is including an Accession Residence Card or a Derivative Residence Card and issued by the Home Office to a non-European Economic Area national who is a family member of a national of a European Economic Area country or Switzerland or who has a derivative right of residence.
A current Immigration Status Document	Must be containing a photograph issued by the Home Office to the holder with a valid endorsement indicating that the named person may stay in the UK, and is allowed to do the type of work in question, together with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
A Certificate of Application	Issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a family member of a national of a European Economic Area country or Switzerland stating that the holder is permitted to take employment which is less than 6 months old together with a Positive Verification Notice from the Home Office Employer Checking Service.
An Application Registration Card	Issued by the Home Office stating that the holder is permitted to take the employment in question, together with a Positive Verification Notice from the Home Office Employer Checking Service
A Positive Verification Notice	Issued by the Home Office Employer Checking Service to the employer or prospective employer, which indicates that the named person may stay in the UK and is permitted to do the work in question

Supporting documents

You must be able to show 2 documents from any of these groups. All driving licenses must be valid i.e. in date and in the correct address. A passport or biometric residence permit can only be used as a supporting document if it's not already been used as a primary document.
